






## Proposal for Cooperation in ICOM's

# INTERNATIONAL OBSERVATORY on ILLICIT TRAFFIC in CULTURAL GOODS

-  A long-term international cooperative platform network between law enforcement agencies, research institutions and other external expert stakeholders
-  An information databank for the network and the public through a Website and a triennial Global Report
-  An innovative tool that will contribute to preventing and fighting the illegal trade in cultural property and related crimes at both national and international levels

## Project summary

Article 17 of the **1970 UNESCO Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property** encourages the conduct of studies by relevant organisations on matters relating to the illicit movement of cultural property. In creating the **International Observatory on Illicit Traffic in Cultural Goods**, ICOM wishes to start a continuous process of **extensive research and reporting**, in close cooperation with a wide range of **international partners**.

ICOM's daily monitoring will gather and compile an unprecedented amount of **information** regarding illicit traffic in cultural goods. The acquired information will be used to implement a dedicated **Website**, which will disseminate all the information available and act as an **activity hub** for ICOM and its partners in this fight. This three-year project will provide a unique permanent monitoring activity and work analysis leading to the publication of the first **Global Report** on the worldwide issue of illegal traffic in cultural property.



The objective of the Observatory is to create a **strong network of project partners** who will contribute to the development of the **Website** and the publication of the final **Global Report**. The Observatory will offer a **private dedicated Web platform**, allowing permanent communication between the different partners. Several **seminars and work meetings** will also be organised in Paris and abroad throughout the project's duration.

The network to be established will help reinforce the **dialogue and cooperation** between its diverse members and foster the development of the collaborative platform. The Observatory initiative will be **largely and internationally promoted** through all ICOM communication tools (magazine, e-newsletter, mailing lists, public events, etc.) to all those concerned by the issue as well as the general public, thus successfully raising general awareness. ICOM's Programmes Department will have a full-time expert staff member working specifically on the Observatory during the **three-year project** for the entire duration of the project.

## Levels of partnership

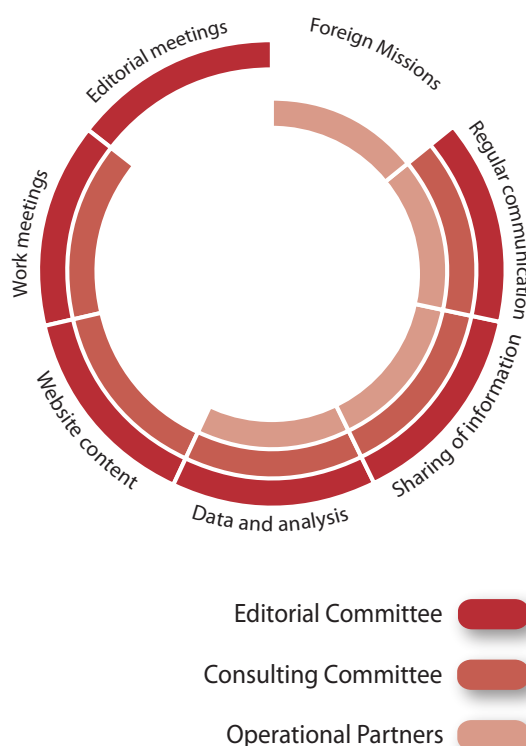
